The year has gone by quickly and I am so proud of the great work and resilience of our students, faculty, staff, alumni, and friends. During the past year, we conducted a virtual graduation for our students due to the COVID-19 Pandemic and remote learning environment. Despite the crisis, many faculties stepped up by serving the communities in need, participated in COVID Testing and provided consultation on COVID related matters.

I was excited to learn that 50% of participating students in the residency pool matched to a program of their choice and several secured fellowships. Many others have jobs now. Many thanks to our Career Coordinators Dr. Jacqueise Unonu and Dr. Estella Lajthia for the post graduate preparatory sessions, and Dr. Earl B. Ettienne, Director of Graduate Programs and Industry Partnerships for the fellowship preparation. We now have 17 sites in 15 countries on 5 continents for international student rotation exchanges/partnerships. Many thanks to Dr. Miranda Law, our International Rotations Coordinator for her hard work growing the international rotations program.

It has been quite a busy year. The Office of Student Affairs under the leadership of Dr. Akiyode pivoted quickly to interview prospective students to ensure we completed our admissions process. Additionally, our Non-Traditional Doctor of Pharmacy (NTDP) Program under the leadership of Dr. Karodeh is in to the second year of in-housing the curriculum. We truly appreciate the hard work of their respective teams to ensure quality processes are implemented for our students.

Our faculty, staff have been very productive this year with 35 publications, 12 presentations, and 16 grants and contracts. 

Dr. Michael Kim, '98 Alumnus, President of Grubb's Pharmacy and Morgan Care Pharmacy collaborated with HUCOP students in partnership with HHS which offered free COVID 19 testing collections sites throughout the Washington DC area this past May 2020.

The three community pharmacies have partnered with the Department of Health and Human Services (HHS) to provide testing to the public free of charge to help address the COVID-19 crisis. Pharmacy staff and students will provide extra support to patients during COVID-19 recovery efforts with drive-up testing.

She is very passionate about the community, coordinating outreach programs to address HIV/AIDS, Diabetes, Immunizations and Heart Disease.

HU Script Your Future Chapter Receives Rookie Award

HUCOP participated in the 2020 Medication Adherence Team Challenge hosted at the NBC 4 Health & Fitness Expo. The Team Challenge is a two-month long inter-collegiate competition among health profession student teams and faculty to raise awareness about the consequences of medication nonadherence.

The Medication Adherence Team Challenge is an integral part of Script Your Future (SYF), a campaign launched by the National Consumers League and its partners in 2011, to combat the problem of poor medication adherence in the United States, where nearly three out of four patients do not take their medication as directed. Non-adherence puts patients, especially those with chronic conditions, such as diabetes or asthma, at risk for serious complications.

HUCOP Script Your Future team kicked off the challenge by hosting their first major outreach event at the NBC 4 Health and Fitness Expo 2020. Several students and faculty participated at the expo by offering free blood pressure, blood glucose, and blood cholesterol screenings. In addition, our "Ask your Pharmacist" booth lead by faculty and pharmacy residents provided education on medication adherence for all participants. This was a collaboration with Howard University Hospital, College of Medicine and College of Dentistry. Our pharmacy students had the opportunity to work side by side with other health

professional students. Additionally, Script Your Future - Howard University (SYF-HU) Team in collaboration with the School of Social work visited the Adam's Place Drop-In Center for the Homeless in early February 2020. The shelter regularly provides services for the homeless populations in the district including anything from showers to career counseling. Our students along with Dr. Tamara McCants added these services by providing adherence counseling and support to groups of participants.

HUCOP Script Your Future (SYF) received the **Rookie award** for their efforts all thanks to the faculty, students and staff that worked hard to make it possible.



Honoring DR. OLU OLUSANYA

FOR OVER 40 YEARS OF SERVICE TO THE COLLEGE

Thank you for your service!

My decision to become a Pharmacist was not by accident, it was rather a determination to complete a profession which my father embarked on but could not complete due to some unprecedented circumstances.

After completing my Higher School Certificate and two years advanced courses in science post regular High School education in Nigeria, I was admitted to Howard University in Fall 1967 and enrolled in the College of Pharmacy. Howard University offered me the best I could wish for. Tuition was only \$250.00 per semester and for the five-year program, my incurred educational expenses was less than \$5000.00. For this, I am eternally grateful to HU for considering that I was a private self-supporting student. That year, there were thirty-two students in my freshman class and in fact that was the largest class that ever enrolled in Pharmacy at that time. Orientation was conducted by Dean Chauncey Cooper, the first Dean of College of Pharmacy, a stern, no nonsense father figure caring person. After his pleasantry welcoming statement, his next statement was, and I quote" look right look left some of you may not be back next semester "a statement an educator will dare not utter today. He was right. Three students did not show up for the spring semester.

The College was blessed with a small number of dedicated and caring faculty most of blessed memories: Dr. Ken Scott, Dr. Leonard Rice, Dr. Roy C. Darlington, Mr. Narendra Shah, Dr. Govind Kapadia, Mr. Floyd White, Mr. James Tyson, Dr. Manoha Sethi and Dr. James Coleman. I'm grateful for their contributions to my pharmacy education.

Fast forward, I obtained my Bachelor of Pharmacy (BS. Pharmacy) in May 1972 and got admitted into the University of Minnesota PharmD program and my class of nine students was the second cohort of the clinical program in the College of Pharmacy. In the early 70s, clinical programs were at its infancy and only few schools offered it as an add on program. I completed the program in May 1974 and joined HU College of Pharmacy on July 1st. 1974 and 2020 will be my 46th year on the faculty at HU. I was one of three clinical faculty hired to develop and implement the clinical program in the college and





that was not an easy task. Didactic clinical courses and rotation sites were developed and just imagine/visualize three clinical faculty members providing clinical rotations for over 50 students, it was a daunting task. Years later, we were able to recruit additional clinical faculty members and since then, I have served in different roles/capacities in the college. Name it, I have done it. The most challenging role was the Department Chairman position which I was appointed to in 1987 by Dean Wendell Hill (blessed memories) and completed in January 2017. The beginning was rough for me for many reasons, which are best not to enumerate at this time, and I would like to thank Dr. Beverly Mims for her unflinching support during that period. The biggest challenge I had was to attract and recruit erudite faculty members to name a few -Dr. Anthony Wutoh who is now the University Provost and Chief Academic Officer of the University, Dr. Daphne Bernard who is now Assistant Provost for Assessment and Accreditation, Dr. Joseph Ofosu the founding Dean of St. Joseph University College of Pharmacy in Connecticut and Dr. Fred Lombardo who holds the highest number of Pharmacy Board Certifications in the US. My other accomplishments were the cooperative service agreement with Washington Hospital Center Department of Pharmacy to provide didactic clinical instructions as well as clinical rotations for our students. We embedded Clinical Faculty members at Children's hospital, VA Medical Center in Washington DC, Providence Hospital, Greater South East Community Hospital, DC General Hospital and Kaiser Permanente. These arrangements expanded our clinical rotations offerings for our students. For me, serving the faculty in my department and the College was my number one priority and I thank all the Deans that I have served in the capacity as Department Chairman for 29 years for their cooperation.

The goal of the grant is to hold education symposium and training programs for pharmacy professionals and other healthcare colleagues regarding pain management and proper use of long acting opioids.


The Opioid Analgesic Risk Evaluation Mitigation Strategies (REMS) was designed to ensure that the benefits of opioid analgesics used in the



outpatient setting outweigh the risks (in patients whose clinicians have determined opioid analgesics to be an appropriate treatment option). The FDA has required manufacturers of opioid analgesics to make education available for providers of these medications. These manufacturers have developed and are implementing this REMS through a consortium known as the REMS Program Companies (RPC). RPC-supported REMS education is provided through accredited continuing education (CE) activities supported by independent educational grants from the RPC. The FDA has developed an Opioid Analgesic REMS Education Blueprint for Health Care Providers Involved in the Treatment and Monitoring of Patients with Pain ("FDA Blueprint") on which the content of these accredited CE activities is based. 


