### Abortifacients: A Community Pharmacist's Role in Medical Abortion Care

**Needs statement:** There has been widespread policy reform regarding abortion care since the overturning of Roe v Wade in 2022. Since 2022, many states have put additional policies in place to protect the right to a safe medical abortion. FDA recently approved of a new combination product, mifepristone, that comprises of mifepristone and misoprostol. This webinar aims to engage community pharmacists on the new REMS Program for mifepristone.

**Statement of goal:** To engage pharmacists in the management of mifepristone and REMS requirements.
